
## #100 The Daniel 2:41-43 Feet of Iron and Clay – The U.S. vs. the USSR in the Cold War

Key Understanding #1: *The <u>second</u> phase of the Daniel 2:41-43 war(s) between the feet of iron and feet of clay.* The <u>Cold War</u> was a <u>second phase</u> of the Daniel 2:41-43 War(s) Between the Feet of Iron and Clay. The results of World War II were the further weakening of the historical European powers of Britain, France, and Germany, leaving the world with two superpowers, the U.S. and USSR. In the simplest of terms, the adversarial and warring relationships of the historical Diocletian and Charlemagne Splits eventually led to the division of the world into two camps – the U.S.-led *West*, which included *West* Germany and NATO, and the USSR-led *East*, which included *East* Germany and the Warsaw Pact nations.

Extra Credit – In school, the professor might have given you an extra credit problem asking you to precisely explain the U.S. vs. USSR Cold War in terms of the Diocletian and Charlemagne Splits. If you are inclined towards working toward a PhD in prophecy, you might write it out yourself. It should look something like this:

During World War II, the *western* part of the *Charlemagne* Split, represented by France, but allied with Britain and the United States as the Western Allies, was allied further with the *eastern* part of the *Diocletian* Split, the USSR. This represented the flanking, or sandwiching, of

Germany, which simultaneously represented the *eastern* part of the *Charlemagne* Split and the *western* part of the *Diocletian* Split. However, as a result of the immediate outbreak of the Cold War at the end of World War II, there was a division of Germany, a division of Europe, and a general division of the world into two camps. In the Cold War division of the West vs. East, the U.S.-led West represented the *western* part of the *Charlemagne* Split of France, and a Western Europe NATO alliance that also included the *western* half of Germany (West Germany). The USSR-led East represented the *eastern* part of the *Diocletian* Split, and was allied with the Eastern Europe Warsaw Pact nations that also included the *eastern* half of Germany (East Germany).

In short, Germany, which had previously represented the *eastern* part of the *Charlemagne* Split, *and* (the *eastern* part of) the *western* part of the *Diocletian* Split, was itself split into two. Its historical role and heartbeat had disappeared, melting away into forced alliances with its former adversaries to the west and east.

Key Understanding #2: *How the Charlemagne Split fits with the East-West Cold War*. In summary, the West-East Cold War was a U.S.-NATO enlarged *western* part of the *Charlemagne* Split, now representing Western Europe in general, vs. a USSR-Warsaw Pact enlarged *eastern* part of the *Diocletian* Split, now representing Eastern Europe.

We are jumping ahead of ourselves just a bit, but in this Cold War <u>second phase</u> of the Daniel 2:41-43 War(s) Between the Feet of Iron and Clay, the U.S.-led West would win, again being in the *Strong Iron* role. The USSR would lose the Cold War and play the role of the *Broken Clay*. (Remember, in the World War II phase of *Strong Iron* and *Broken Clay*, we saw Kenneth *Strong* and the 'Man of *Iron*' Eisenhower defeat *Broken Clay* Germany).

If you are following closely, this question might be on your mind. Does this mean that the U.S. was placed in the historical role of France as the representative of the *western* part of the *Charlemagne* Split? The answer is 'yes', and we are now ready to understand much more about the United States in prophecy.
