#960 The Whore's Latter Rain – The Protestant Reformation's (counterfeit) Latter Rain of April 6 [= 9], 1917, through the U.S. entry into World War I, part 2, The Son of Joel Flood, Henry de la Warr Flood




Henry de la Warr Flood. Henry de la Warr Flood (*left*) was the son of Confederate Major Joel Flood, of Appomattox County, Virginia. He was born on September 2, 1865, on the family estate, 'Eldon'. He was in his mother's womb when Confederate General Robert E. Lee surrendered to Union General Ulysses S. Grant on April 9, 1865, at nearby Appomattox Court House.

[Note: Today, the county seat of Appomattox County, Virginia, is Appomattox. Three miles to the northeast, at the county seat *at that time*, in a little village known as Appomattox Court House (because the county courthouse was there), Lee surrendered to Grant. Appomattox Court House was virtually deserted after

the county seat was moved to the new town of Appomattox in 1892. However, Appomattox Court House was made a national historical monument in 1940. The buildings at the 968-acre area of Appomattox Court House include the Appomattox courthouse and the McLean House, which was the actual meeting site of the two Civil War generals.]

De la Warr. Henry de la Warr Flood's middle name, de la Warr, translates to "of the war," which is appropriate since God ordained that he was in his mother's womb *at the <u>time when</u> the Civil War ended, and at the <u>place where</u> the Civil War ended.* The name de la Warr was




actually in the family's history, however, from Lord de la Warr, Thomas West, who rebuilt Jamestown, Virginia, in 1610. The state of Delaware is named after Lord de la Warr.

From the Civil War to World War I. Henry de la Warr Flood, the child whose birth represented <u>the end</u> of the <u>Civil War</u> on April 9, 1865, at Appomattox Court House, Virginia, would, as a congressman from Virginia, become the person who would represent <u>the beginning</u> of U.S. involvement in <u>World War I</u>, on April 6, 1917, as the author of the resolution declaring a state of war to exist between the United States and Germany.

Joel 2:23 (KJV) Be glad then, ye children of Zion, and rejoice in the LORD your God: for he hath given you the <u>FORMER RAIN</u> moderately, and he will cause to come down for you the rain, the <u>FORMER RAIN</u>, and the <u>LATTER RAIN</u> in the first month.

Key Understanding: *Joel's latter rain of April 6 [= 9], 1917.* Through <u>Joel Flood</u> and his son, Henry de la Warr <u>Flood</u>, author of the war resolution for the U.S. to enter World War I, it can be seen that the Men o' War April 6 [= 9], 1917, second part of the second phase of the Woodrow Wilson-led Protestant Reformation is connected to the idea of it being of Joel's Latter Rain of God – the idea ultimately being that it was an outpouring of the Spirit causing the rise and spread of the Fourth Rome's Christian Democracy. Furthermore, the Joel's Latter Rain of April 6 [= 9], 1917, is coupled with its double of the Latter Rain Pentecostal movement of 11 years before, which is also said to be Joel's Latter Rain.



Buried at Appomattox Court House. Henry de la Warr Flood is buried in a mausoleum on the courthouse green at Appomattox Court House, the village where Lee surrendered to Grant to end the U.S. Civil War.

Here is **#960–Doc 1**, **the Congressional Biography of Henry de la Warr Flood**. [If you read the biography, you will note that Henry de la Warr Flood had a brother, Joel West Flood. His brother Joel obviously took on their father's name, Joel, but also had the middle name of West, probably to represent Thomas West, Lord de la Warr, just as Henry de la Warr Flood would have been given the middle name of de la Warr, to represent the same person.]
