


#1112 The Door of Heaven and the Gate of God – The Two Eliakims: The *second phase* of the curse of the *second* Eliakim (Jehoiakim) and the curse of Elijah (Malachi 4:6), part 24, The Curse of the Kennedy Children

The Curse of the Kennedy Children. What is called the “Kennedy Curse” [we first introduced this in Unsealing [#1092](#)] has as its most famous event the November 22, 1963, assassination of U.S. President John F. Kennedy. The “Curse of the Kennedys” is primarily focused on the theme of the “curse of the Kennedy *children*.” During the 20th century, the Kennedys were America’s “First Family.” Here is a list from one source of the events and deaths that are part of the so-called “Kennedy curse.”

- Joseph P. Kennedy, Jr., Joe’s eldest son, the great hope of his father for the American Presidency, is killed in a plane crash in 1944, aged twenty-nine.
- Kathleen Kennedy, Joe’s second daughter, dies in a plane crash in 1948, aged twenty-eight.
- **John F. Kennedy, 35th President of the U.S., is assassinated in Dallas in November 1963, aged forty-six.**
- John F. Kennedy’s son, Patrick Bouvier Kennedy, born prematurely to the President and his wife in 1963, dies three months before his father’s assassination.
- Robert F. (Bobby) Kennedy, Joe’s third son, is assassinated in June 1968, aged forty-two.
- Edward M. (Ted) Kennedy, Joe’s youngest son, drives a car off a bridge on Chappaquiddick Island in July 1969, after a party. His aide, Mary Jo Kopechne, is found dead in the submerged car.
- Bobby Kennedy’s son Joseph is involved in 1973 in a car accident which leaves a female passenger paralyzed for life.
- Ted Kennedy’s son, Edward, Jr., has his right leg amputated in 1973 because of cancer.
- Bobby Kennedy’s son David dies in 1984 of a drug overdose.
- Ted Kennedy’s son Patrick is treated for cocaine addiction in 1986.
- Ted Kennedy’s nephew, William Kennedy Smith, is acquitted of rape in 1991.
- Bobby Kennedy’s son Michael is killed in a skiing accident in December 1997, aged thirty-nine.
- John F. Kennedy’s only surviving son, JFK, Jr., dies in a plane crash in July 1999, aged thirty-eight.



Malachi 4:5-6 (KJV) Behold, I WILL SEND YOU ELIJAH the prophet before the coming of the great and dreadful day of the LORD:

Key Understanding: The Malachi 4:6 “curse of Elijah” is the prophetic root of what is called the “Kennedy Curse.” John F. Kennedy was born on May 29, 1917, exactly 2 months after Man o’ War was born on March 29, 1917, and thus in conjunction with the U.S. Man o’ War entry into World War I. The Malachi 4:6 “curse of Elijah” is the prophetic root of what is called the “Kennedy Curse.” In other words, the Lord ordained the “curse of the Kennedy children” to verify the timing of his implementation of the fulfillment of the Malachi 4:6 “curse of Elijah,” which has incorporated with it the “curse upon Jezebel’s children.”

[Note: The meaning of Kennedy’s birth was first covered in Unsealing [#955](#) The Whore’s Latter Rain – Clarifying April 9, 1906, and the Protestant Reformation, and April 6 [= 9], 1917, and the Protestant Reformation. Here is what was written:

We don’t want to get sidetracked from our main focus, yet this is the perfect time to mention that of all the people to be born in prophetic conjunction with the Protestant Reformation/Christian Democracy event of the April 6 [= 9], 1917, U.S. entry into World War I, it was **John F. Kennedy**, the only Roman Catholic President of the United States in its history. Kennedy was born on May 29, 1917, in Brookline, Massachusetts, exactly 2 months after Man o’ War’s birth on March 29, 1917. Man o’ War, of course, is entirely representative of the Protestant Reformation’s World War I endeavor of ‘Making the World Safe for Democracy.’ So why would the Lord ordain the birth of the only Roman Catholic U.S. President at that time, in conjunction with such a Woodrow Wilson-led Protestant-oriented event? The answer is that the Lord was showing that the spirit and doctrines associated with the *sword-bearing*, men o’ war, ‘church/state’ trunk of the Protestant Reformation, which produced the *second ascension* of the Revelation 17:3 *scarlet* Beast United States in 1917, are an extension of the all-encompassing *scarlet* Mother of Harlots Roman Catholic Church. This is why John F. Kennedy’s famous reply concerning his Roman Catholic faith during his run for the Presidency in 1960 was, “No one asked me my religion {when I was fighting for America} in the South Pacific {during World War II}.” Clearly, John F. Kennedy’s ultimate religion was that of most American Protestants, and that was the worshipping of the Beast out of the Pit.]
