Key Understanding: *U.N. Resolution 242*. U.N. Resolution 242 of November 22, 1967, became the world's bedrock of the efforts to forge peace between Israel and the Arabs.

Resolution 242 and the 1973 Yom Kippur War Resolution 242 and the Camp David Accords of September 17, 1978 Resolution 242 and the Saudi Peace Plan and the Fez Declaration

Resolution 242 and President Reagan's Peace Plan

President Reagan's Peace Plan (September 1, 1982) reaffirmed Resolution 242 and emphasized its application to all occupied territories. "Both resolutions (242, 338) have been the basis of all U.S. peace initiatives since 1967, including the Rogers Plan, [the] Camp David Accords, the <u>Reagan Plan</u>, and the Madrid Conference."

Resolution 242 and the 1991 Madrid Conference

For years, a succession of U.S. administrations demanded, as a precondition for Palestinian entry into the peace process, that the Palestine Liberation Organization (PLO) formally

accept U.N. Resolution 242 and recognize not only Israel's existence but its "right to exist." Meanwhile, in July 1988, the nation of Jordan, which controlled the West Bank area prior to the 1967 Six-Day War, when it lost the West Bank region to Israel, formally relinquished its claim to the West Bank in favor of Palestinians. [King Hussein of Jordan made this decision so that Jordan could bow out of the difficulties of representing the Palestinians in the issue of a Palestinian homeland in the land of Palestine, handing the responsibility over to the Palestinians themselves, who were represented by Yassir Arafat and the PLO.] In November 1988, the PLO, in an acceptance of U.N. Resolution 242, formally relinquished all Palestinian claim to

territory inside Israel's pre-1967 Six-Day War borders, recognized Israel's "right to exist," but also declared its goal to be the establishment of an independent Palestinian state in the West Bank and Gaza, existing alongside Israel, with a shared capital of Jerusalem. Three years later, and only because of their acceptance of U.N. Resolution 242, Palestinians were included for the first time in peace negotiations, participating as part of the Jordanian delegation to the Madrid peace conference convened by U.S. Secretary of State James Baker in October 1991.
