

#2032 The Yom Kippur War and the Abomination of Desolation – The post-World War II U.S. waxing great toward the South and toward the East as a *second* Syria/Antiochus IV Epiphanes, part 291, **The Stern Gang, (xv), The *double* events of August 31-September 1, 1939, that would lead to (i) Hitler fulfilling his role as the *stern-faced king* in Germany and Poland, and (ii) the Stern Gang being formed in Palestine**

Review (from the previous Unsealing): The fulfillment of the *stern-faced king* in Daniel 8:23 – with the Jewish Holocaust significantly in its midst – surrounds, involves, and entwines the four (4) nations of Germany, the United States, Great Britain, and Israel.

Key Understanding #1: *The double August 31-September 1, 1939, events. There were double events that occurred on August 31-September 1, 1939, that would lead to (i) Hitler fulfilling his role as the competing stern-faced king, and (ii) the Stern Gang being formed in Palestine.*

- (i) **August 31–September 1, 1939, Hitler and the start of World War II** – On August 31, 1939, German troops staged a phony invasion of Poland so as to justify Germany’s invasion of Poland the next day, September 1, 1939.
- (ii) **August 31-September 1, 1939, and the Stern Gang** – Separate and independent from the event of Germany’s invasion of Poland on August 31-September 1, 1939, to begin World War II, the entire command of Irgun, including Abraham Stern, was arrested by the British in Tel Aviv, Palestine, the same day. After being released from prison in 1940, Abraham Stern birthed the new faction, the Stern Gang.

Key Understanding #2: *The double August 31-September 1, 1939, events were interconnected. Remarkably, though originating separately and independently from one another, the two events of (i) the August 31, 1939-September 1, 1939, start of World War II, and (ii) the August 31-September 1, 1939, arrest of Irgun that would eventually lead to the formation of the Stern Gang by Abraham Stern, became interconnected both historically and prophetically because the formation of the Stern Gang by Abraham Stern occurred mostly because of the issue of Irgun’s desire to support Great Britain against the Jew-oppressing Nazis after the September 1, 1939, outbreak of World War II, while Abraham Stern desired to collaborate with the Nazis against the occupier of Palestine, Great Britain.*

Key Understanding #3: *The interconnectedness of the double stern-faced events of August 31-September 1, 1939. The remarkable aspect is that the Lord ordained both (a) the reason for the genesis of the Stern Gang (that the Jews should support anyone who was an enemy of Great Britain in World War II) and (b) the *timing* of the genesis of the Stern Gang (after*

the August 31-September 1, 1939, arrest of Irgun leaders and members) to be entirely connected to the competing stern-faced king's actions on August 31-September 1, 1939, that began World War II.

*Daniel 8:23 (NIV) "In THE LATTER PART OF THEIR REIGN, when rebels have become completely wicked, A STERN-FACED KING [a competing stern-faced king, represented by Adolf Hitler and Nazi Germany through the event of Kristallnacht, November 9-10-11, 1938, which can be considered a beginning to the Holocaust, and the primary stern-faced king, represented by Irving Berlin and the United States and Winston Churchill of Great Britain], *a master of intrigue, will arise.**
