

#2045 The Yom Kippur War and the Abomination of Desolation – The post-World War II U.S. waxing great toward the South and toward the East as a *second* Syria/Antiochus IV Epiphanes, part 304, **Nuremberg Day of Judgment, (vii), The Nuremberg Trials**

**The Nuremberg Trials.** The Nuremberg Trials were a series of trials most notable for the prosecution of prominent members of the political, military, and economic leadership of Nazi Germany. The trials were held in the city of Nuremberg, Germany, from 1945 to 1949, at the Nuremberg Palace of Justice. The first and best known of these trials was the Trial of the Major War Criminals before the International Military Tribunal (IMT), which tried 24 of the most important leaders of Nazi Germany. However, only 21 were present at the trial. Robert Ley committed suicide before the trial began.



November 20, 1945: The Nuremberg Trials begin. 24 high-ranking Nazis are held accountable for atrocities perpetrated during World War II. The trial was the first of its kind in history, conducted by British, Soviet, American, and French judges.

Gustav Krupp was considered too frail to stand trial. Martin Bormann was missing but tried *in absentia*. The indictments were read on November 20, 1945, and the trial lasted to October 1, 1946.

Each of the accused were charged with one or more of the following:

**Count I: Conspiracy to Wage Aggressive War** (also characterized as “conspiracy to commit crimes alleged in the next three counts”)

**Count II: Crimes against Peace**

**Count III: War Crimes**

**Count IV: Crimes Against Humanity**

**Key Understanding: The key verse that prophetically draws together the Nuremberg story is Matthew 27:25.**

**Matthew 27:22-26 (KJV)** Pilate saith unto them, What shall I do then with Jesus which is called Christ? They all say unto him, Let him be crucified.

23 And the governor said, Why, what evil hath he done? But they cried out the more, saying, Let him be crucified.

24 When Pilate saw that he could prevail nothing, but that rather a tumult was made, he took water, and washed

his hands before the multitude, saying, I am innocent of the blood of this just person: see ye to it.

25 **Then answered all the people, and said, HIS BLOOD BE ON US, AND ON OUR CHILDREN.**

26 Then released he Barabbas unto them: and when he had scourged Jesus, he delivered him to be crucified.
