Key Understanding (which is the same as is in the previous Unsealing): The dispute over the Polish Corridor, which included Hel Spit. The Polish Corridor refers to a corridor of land that allowed Poland to be linked to the Baltic Sea, which encompassed land that belonged to Germany in World War I, and, furthermore, which now split in two what was part of Germany during World War I. Adolf Hitler's premise for beginning World War II significantly surrounded the dispute over the city of Danzig (Gdansk, Poland today) and the Polish Corridor, which included Hel Spit. The spiritual/prophetic and even historical point is that the Lord ordained the land (the Polish Corridor) that included the Hel Spit to be directly linked to Hitler's excuse for the invasion and occupation of Poland – which led to the death of millions of Jews - for the purpose of illustrating that the Lord was

not going to be mocked concerning the mocking of, spitting upon, striking of, and crucifixion of his Son, Jesus Christ.

**The Polish Empire.** To begin to understand the Germany-Poland dispute over the Polish Corridor leading up to World War II, let's first look at a map (*right*) of Poland several hundred years ago.

In 1025, the first king of Poland was crowned. In 1386, Queen Jadwiga of Poland married Wladyslaw Jagiello, the Grand Duke of Lithuania. The Polish-Lithuanian Commonwealth was ruled by Jagiellonian kings for nearly 200 years, and under their leadership, the Polish Empire reached great heights, covering even the Ukraine and regions that much later would be a part of the

Soviet Union. Note that in the map *above* Gdansk is shown to be under the control of "Royal Prussia," but "Royal Prussia" was actually a protectorate of the Polish Empire. In the map shown in #2095–Doc 1 *below*, which depicts the greatest extent of the Polish Empire around 1635, Gdansk is shown to be under direct Polish control. What had occurred was that the region of the Polish Corridor, Hel Spit, and Gdansk underwent the sparring between the Teutonic Knights (or Prussians) and the Polish Empire, with different results and arrangements over the course of several centuries. The people who ended up living in Gdansk (Danzig) were mostly Germans. For the prophetic purpose of understanding how that helped lead to Hitler's invasion of Poland in World War II, it is simply important to remember that both Germany and Poland had their roots in the region for centuries.
