Key Understanding #2 (which is the same as is in Unsealings <u>#2094–#2098</u>): *The dispute over the Polish Corridor, which included Hel Spit.* The Polish Corridor refers to a corridor of land that allowed Poland to be linked to the Baltic Sea, which encompassed land that belonged to Germany in World War I, and, furthermore, which now split in two what was part of Germany during World War I. Adolf Hitler's premise for beginning World War II significantly surrounded the dispute over the city of Danzig (Gdansk, Poland today) and the Polish Corridor, which included Hel Spit. The spiritual/prophetic and even historical
