Hitler prepares to invade Poland, using Danzig as a source of friction. Germany wanted a revision of its eastern frontier to include the Polish Corridor – which included within it Hel Peninsula and the city of Hel – and Danzig back under German control.



"Danzig is German". Postage stamp issued by Nazi Germany to celebrate the annexation of Danzig by the Third Reich after the invasion of Poland. On April 3, 1939, Part 2 of the annual directive for the German armed forces, drafted by Hitler himself, set forth a strategic outline for an attack

on Poland to be prepared by September 1, 1939. On April 28, in his first open move, Hitler abrogated the Polish-German non-aggression treaty of 1934 and declared that the issue of Danzig (Gdansk) must be settled. Hitler's turning against Poland surprised no one. On March

31, the British government, attempting to forestall the German dictator, had given a unilateral guarantee of Poland's territorial integrity.

The August 23, 1939, Nazi Germany-Soviet Union non-aggression pact. Hitler did not want

war on two fronts. Negotiations began with the USSR that would result in the August 23, 1939, Nazi-Soviet non-aggression pact (which Hitler would break with the German invasion of the Soviet Union in Operation Barbarossa on June 22, 1941). What this meant was that Hitler could invade Poland (which occurred nine days later on September 1, 1939) without Russian interference, and, in fact, actually established the specific plan for a forthcoming division of Poland with the USSR. The pact is also called the Ribbentrop-Molotov Pact, named after Soviet foreign minister Vyacheslav Molotov and German foreign minister Joachim von Ribbentrop.

Key Understanding (which is the same as is in Unsealings #2094-#2100): The dispute over the Polish Corridor, which included Hel Spit. The Polish Corridor refers to a corridor of land that allowed Poland to be linked to the Baltic Sea, which encompassed land that belonged to Germany in World War I, and, furthermore, which now split in two what was part of Germany during World War I, Adolf Hitler's premise for
