Monroe vs. the 1815 Holy Alliance. [Reference Unsealings #74–#75, #155, and #1725.] One of the major purposes of U.S. President James Monroe's Monroe Doctrine was to counter any decision made by the Holy Alliance of Prussia (Germany), Austria, and Russia to aid Spain in regaining territories that had declared their independence in Latin America. In doing so, the motive of the Holy Alliance would have been to curb revolutions against autocratic rule in Europe.

The 'New World vs. Old World' situation created by the Monroe Doctrine, which supported the independence of colonies from their European colonial overlords, and thus was in basic opposition to possible motives of the Holy Alliance of Prussia, Austria, and Russia to aid Spain in

regaining Latin American colonies that had declared independence in the New World, presaged the geo-political (and prophetic) development during World War I when the United States, representing Christian Democracy, became the Fourth Christian Rome, at the time of the demise of the Prussian, Austrian, and Russian Empires, which had represented Christian Autocracy.





After the defeat of Napoleon, on September 26, 1815, in the name of the Trinity, the so-called Holy Alliance was proclaimed by the Tsar of Russia, and the Austrian and Prussian empires.
