




Just as Jesus Christ is the *husband* and *head* of the 'holy nation' Church – the *body* of Christ – U.S. Presidents George Washington and George H.

Here is #438–Doc 1, which includes a description of the April 30, 1789, inauguration of George Washington and the administering of the oath of office by Robert R. Livingston. Modern presidents are sworn in by the Chief Justice of the U.S. Supreme Court, but it was not yet established. Therefore, Livingston, the chief judge of New York State, administered the oath.
